### Holden brand to cease operation in Australia in 2020

The Holden brand will be retired by 2021 in Australia and local design and engineering departments all-but shut down, General Motors has confirmed.

In what is monumental news for the Australian automotive industry, Holden's Melbourne design studio and Lang Lang proving ground are expected to shut with up to 600 of 800 local jobs lost.

#### **Shannons Wheels 2020**

The annual Shannons Wheels vehicle display is hoped to attract more than 1000 classic, historic veteran, vintage cars, trucks and motor bikes to be displayed at the Queanbeyan Showground on Sunday 1 March 2020.

Gates open to the public from 10am. Entry is by a gold coin.
