60 day usage scheme introduction delayed

The 60-day usage and modified vehicle scheme introduction has been delayed until the fourth quarter of 2021.

The delay has been necessary due to some administrative concerns raised.

The logbook –based scheme allows owners of vehicles of 30 plus years old to use their registered vehicles for 60 days in any one registration year. The ACT scheme is like other 60-day usage schemes operating in other states.

The Council will disseminate the details and procedures as soon as possible to enable clubs to inform and see an orderly introduction.

CACTMC Affiliations due by 30 June

All clubs affiliated with the Council of ACT Motor Clubs are required to renew their affiliation by 30 June 2021.

Annual affiliation requires the submission of an affiliation form (detailing the Club's nominated Council liaison officers) and payment of the affiliation fee. If applicable, a current Authorised Club Signatories form and a current list of the Club's endorsed concessionally registered vehicles (ACT & NSW) is also required.

Note if a Club fails to affiliate by 30 June 2021 then the Club's members vehicles that are endorsed for Concessional Registration by

that Club may be deemed unregistered and therefore should not be used on public roads - until re-affiliation is effected.
