- **LOOSE ARRANGEMENT BETWEEN GOVERNMENT AND COUNCIL FROM 1986, ONE PAGE 2006!**
- **COUNCIL PROPOSED FORMAL MEMORANDUM OF UNDERSTANDING (MOU) IN MAY 2018**
- **FINALLY APPROVED IN DECEMBER 2022**
- **DEFINES RESPONSIBILITIES, CATEGORIES AND RULES. COPY ON COUNCIL WEBSITE**

INTRODUCTION

CRS IS A PRIVILEGE NOT A RIGHT

- ANTICIPATE LETTER FROM ACCESS ADVISING OF NEW CONDITIONS OF REGISTRATION AND USE. WILL PROVIDE INFORMATION ABOUT LOGBOOK COLLECTION AND START DATE OF 3 APRIL
- GOVERNMENT/COUNCIL **MOU WILL BE ON COUNCIL WEBSITE;** OUTLINES CONDITIONS AND RULES
- **NEW COUNCIL BY LAWS** WILL BE ISSUED
- SUGGEST CLUBS COPY TO THEIR DOCUMENTATION

MODIFIED HISTORIC

- **CATERS FOR RODS, STREETCARS AND OTHER MODIFIED VEHICLES**
- **OVER 30 YEARS OLD**
- **FOR VEHICLES THAT DO NOT MEET VVH CRITERIA**
- **ENTRY REQUIREMENTS/QUALIFICATION**
- **INITIAL INSPECTION (OR PRODUCTION OF CERTIFICATION) FOR ELIGIBILITY TO CONFIRM MECHANICAL ROADWORTHINESS COMPLIES WITH RULES. IE VSB14**



USAGE CRITERIA FOR ALL CATEGORIES

60 DAYS

- Personal use for 60 days per annum
- Log book controlled and recorded **BEFORE** departure
- No Restrictions (except no hire and reward. IE Commercial activity)
- Every day is one days use; go past midnight –two days.
- **MAINTENANCE INCLUDED**



CLUB RUNS

- **PUBLISHED IN MAGAZINE OR ON WEBSITE ETC (NO WORD OF MOUTH)**
- **RUNS WITH OTHER CLUBS –ADVISE REGISTRAR ; RECORD REQUIRED**
 - **STANDING ADVICE ACCEPTABLE FOR DUAL CLUB PARTICIPATION**
- **RALLIES INTERSTATE; BONA FIDES TO BE CHECKED AND RECORDED BY REGISTRAR BEFORE APPROVAL; OTHERWISE 60 DAY USE**
- **ACT CLUB RUNS IN LOCAL AREA (INCLUDING NSW) ARE NO PROBLEM**
- **IMPROMPTU CLUB RUNS; REGISTRAR ADVISED FOR RECORDING DETAILS**
- **MUST BE RECORDED IN LOGBOOK BEFORE DEPARTURE!**



CLUB MANAGEMENT

- **INSPECTION**

- SAME AS EXISTING RULES
- NEW FORMS TO CATER FOR HISTORIC MOD INSPECTION CERTIFICATION

- **ENSURE USE COMPLIANCE**

- VET APPLICANTS – WEED OUT CHEAP REGO SEEKERS.
- CONSIDER LIMITS TO INITIALLY ACCESS SYSTEM (EG TIME, 6 MONTHS AND CLUB PARTICIPATION)

PICKUP ; ACT DRIVERS LICENCE

CLUB CARD /CURRENT MEMBERSHIP PROOF

CLUB MEMBERSHIP TO BE ENDORSED BY CLUB REGISTRAR/PRESIDENT/SECRETARY

SERIAL NUMBER LINKED TO REGISTRATION BY ACCESS CANBERRA

FIVE YEAR VALIDITY

NON TRANSFERABLE. - SELL VEHICLE ; BOOK NO LONGER VALID

REPLACEMENT REQUIRES CLUB ENDORSEMENT

FRONT: PERSONAL 60 DAY PAGES. FIVE SECTIONS; ONE FOR EACH YEAR

BACK: CLUB RUNS – NO LIMIT

MUST BE CARRIED IN VEHICLE

PENALTIES FOR NON COMPLETION BEFORE RUN **(VEHICLE NOT COMPLYING WITH REGISTRATION CONDITIONS)**

UP TO \$900

Period of Club Membership



NUMBERPLATES



- EXISTING VVH PLATES WILL REMAIN
- NEW PLATE FOR MODIFIED HISTORIC.
- PLATE RATIONALE- CONCESSION; SPECIFIC GROUPS LIKE TAXIS, HIRE CARS, ETC, IDENTIFIABLE AS HOBBY VEHICLE
- GOVERNMENT HAS STATED ANY PLATE **'AVAILABLE TO THE GENERAL PUBLIC MAY BE USED'**
- NO HEAVY VEHICLE PLATES ALLOWED



- **REMINDER FOR ALL REGISTRARS**
- **TELL COUNCIL REGISTRAR OF ALL VEHICLE SALES /DISPOSALS (FOR REGISTER)**
 - **GET YOUR MEMBERS TO TELL YOU NEW REGO DETAILS**
 - ENTER IN YOUR CLUB REGISTER (LEGAL REQUIREMENT TO HAVE ONE)
 - ADVISE COUNCIL REGISTRAR BY EMAIL OF;
 - **YEAR**
 - **MAKE**
 - **MODEL**
 - **COLOUR**
