The Council of ACT Motor Clubs Inc. cordially invites your participation at *Wheels of Canberra 2026* at Thoroughbred Park on Sunday 22nd March.

Wheels of Canberra is the Council of ACT Motor Clubs' (CACTMC) annual heritage motoring enthusiasts' display.

2026 marks the 45th occasion of this prestigious event and will be held at **Thoroughbred Park**.

Wheels of Canberra is open to all marques and is attended by many motoring enthusiasts from ACT and regional NSW. The featured vehicles for 2026 are: Military & Service Vehicles; and classic MGs.

In recent years there have been approximately 550 vehicles on display, representing most of the major current and former manufacturers from the early 1900s to present day vehicles.

As has been the practice at **Wheels of Canberra** in recent years:

Cars that want to PARK TOGETHER - should ARRIVE TOGETHER.

Exhibitor Tickets:

Pre-Paid tickets will be available (to be collected at a CACTMC General Meeting) for \$5 per vehicle. Tickets purchased on the day will be \$10 per vehicle and only available at **Gate #1**.

Trade & Dealerships:

A dedicated area is being set aside for pre-registered automotive trade vendors and dealerships. Access will be via **Gate #2** off Randwick Road. Please refer to the **Trade Space Application** form below.

The vendor sites are nominally about 5m x 5m. However, if additional space is required, this can be accommodated but please discuss with us first to ensure the location allocated is suitable.

Access to vendors sites is available from 8:00am on Sunday 22nd March – i.e. the day of the event. Vendors should endeavour to have their site set up by 9:00am at the latest and should remain in place until 2:00pm.

We are offering two levels of premium vendor site:

Small site (for sole traders) @ \$150.00

Large site (for corporate organisations) @ \$250.00

A tax invoice can be provided.

Wheels of Canberra is being run in conjunction with *Thoroughbred Park* who will be providing food & non-alcoholic drink stalls near the Grandstand. NB: Wheels of Canberra is a 'dry' event.

The combination of events on offer mean that it will be an ideal outing for the whole family, with plenty to interest the Mums, Dads and the kids on the day.
